PURSUANT TO S. 167.10 STATS.

The Chairperson for the Town of Bradley does hereby issue this permit to the group of resident or nonresident individuals whose names are shown on the reverse. This permit authorizes such group to purchase, possess, and use the kind and quantity of fireworks (as defined in s 167.10 Stats), and as specified below, within the Town of Bradley, on the date specified and at the location specified. This permit is void to any person under the age of 18 years, and is subject to the conditions stated thereafter, and all applicable provisions of s. 167.10 Wisconsin Statutes, all applicable Town of Bradley ordinances, and the terms and conditions stated on the application.
