M/M Koth/Hilgendorf to approve operator's licenses for Joelle Lund, Kenneth Fritzke, Jessica Rozell and Tracy Kaiser. Motion Passed 4-0. The operator's license for Jacob Schaper was denied due to previous offenses.

M/M Hilgendorf/Jelinek to approve the request from Arnott Plumbing to install a septic system on partial road right-of-way for Seely Katzenberg on property located at N11664 Roberts Road. Town chairman will sign off on a letter of approval once typed. Motion Passed 4-0.

M/M Hilgendorf/Koth to continue with Tom Emmer for the mowing/cleaning at the parks and beach. The Bradley Town Hall was also added to that contract and approval was made to do a two year contract with Tom covering the 2017 and 2018 season. This contract is in the amount of \$9,200.00 per year for the two year term. Motion Passed 4-0.

Road Report was given by Byron Lange - Klade road has some cutting and clean-up yet to do on it.
