- 1) Call to Order: Chairman Kevin Koth called the meeting to order at 5:30pm. Present were Supervisors Bill Jelinek, Joan Hilgendorf and Bob Eisenman.
- 2) Pledge of Allegiance
- 3) Public Comment: None
- **4)** Treasurers Report: Building & Office Equipment Fund-\$107,873.63; Equipment Fund \$159,581.42; General Savings Account \$275,452.52; Checking Account \$184,608.76; Cemetery Fund \$117,887.32; Re-Evaluation \$30,000.00; and Greenwood Cemetery Beautification Fund \$12,393.49.
- 5) Minutes of Previous Meeting: February 12, 2018 Hilgendorf/Eisenman motion to approve. Motion passed 4-0
- 6) Clerk's Business
  - A. Payment of vouchers #4923 through #4979-Hilgendorf/Eisenman motion to approve. Motion passed 4-0.
  - B. Operators license for Dawson Beck & Rebekah DeWitt Koth/Hilgendorf motion to approve. Motion passed 4-0
- 7) Correspondence None
- 8) Resolution for Lincoln County Zoning related to zoning code and shoreland zoning standards. As there were no objections Eisenman/Hilgendorf motion to approve. Motion passed 4-0.
- 9) Parks Mowing/Cleaning Last year there was a two year contract signed with Tom Emmer to provide services at the parks, beach, and town hall. That contract was signed for a total of \$9,200.00 for the maintenance year. It was also decided that OJ Services will provide cleaning of the port-a-potties at Kahle Park and the beach on a bi-weekly basis with them providing toilet paper, airfreshner, cleaning and chemicals. They will also provide cleaning at the cemetery port-a-potty on a monthly basis.
- **10)** Taylor Cemetery Lots The Taylor family had originally purchased eight lots and there are still four open lots. Their daughter Leah Sukhram has requested ownership of the lots but was unable to find a deed. Hilgendorf/Koth motion to approve creating a new deed for the remaining four lots to Leah Sukhram. Motion passed 4-0.
- **11)** Fuel Tank Bids Two bids came in one from Ken Kraklow in the amount of \$400.00 and one from Foley's Tree Service in the amount of \$850.00. The bid was awarded to Foley's Tree Service.
- **12)** Waste/Recycling: As of April 3, 2018 will be going down to one dump worker. If it seems to get busy during the summer hours will look at increasing to two again. Tomahawk Iron and Metal has agreed to provide dumpsters at their site for residents to drop off leaves. They will be charging a flat fee of \$1400.00 to the town for providing this service. Supervisor Jelinek will meet with them to set up dates and times.
- 13) Plan Commission: Conditional use request by Ryan Wolf & Randy Buhr to build a storage building on Coda Lane in the Town of Bradley. Koth/Hilgendorf motion to approve. Motion passed 4-0. The next plan commission meeting is scheduled for March 26, 2018 at 6:30pm.
- **14)** Road Report: Weight Limits will go on effective Friday, March 16th. The two new road workers will be attending a work zone/flagger safety class in Wausau on May 8th. The proposals for blacktopping, pulverizing, grubbing and crack filling will be posted in the Tomahawk Leader on March 20th and 27th.
  - Any other business not requiring board action: Letter will be sent to Property Connections as they are behind again on payments. Work will need to be done at Theisen Park to get the lower field cleaned up.
