Road Report: The decision was made to proceed with the work on Kings Road. The plan is to send out letters to the residents where tree cutting and shouldering will take place. Trees will be removed, grubbing done, and shoulders put in for the safety and maintenance of the road. Work will not take place until later in the year, Hilgendorf/Eisenman motion to approve the work. Motion passed 4-0. The necessary work will be completed at the Muskellunge Lake Boat landing; the plan is to remove the six old planks and install 10 new planks. The Muskellunge Lake Association had agreed to pay for half of the cost for the work so once all pricing is in we will be contacting them. The TRIPS road projects have all been submitted to the state. The county will be painting the center line on Crass Road.

Cemetery Report: They are still working on getting the pond up and running. Supervisor Jelinek is still working on the plans for the scattering garden as well as adding a columbarium.

Parks & Beach Report: Supervisor Eisenman is still working with the county and DNR regarding Crystal Beach and permits. Discussion was held on the best way to proceed with clean-up at Theisen Park. Will contact the insurance company regarding the roof on the school at Kahle Park.

Building & Grounds: Supervisor Hilgendorf requested the bugs get cleaned off the town hall as well as the road garage.
