- Cemetery Report: The dates have been adjusted for the removal of cemetery decorations. All decorations will need to be off by May 1st and new decorations may be placed starting on May 6th. The board will look at adjusting the prices for burials, etc. for Greenwood cemetery at the May meeting.

Road Report:
