Town Board Meeting May 13, 2019 5:30pm Bradley Town Hall

Chairperson Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf, Robert Eisenman and Bill Jelinek were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$98,508.59 Equipment Fund - \$187,709.84; General Savings Account - \$394,783.08; Checking Account - \$90,019.81; Cemetery Fund - \$100,813.58; Re-Evaluation - \$45,000.00 and Greenwood Cemetery CD - \$12,424.56.

Koth/Jelinek motion to approve American Asphalt to blacktop Wurl, Acorn, Crystal Lake, Wurl (stub.), Deer Point, Short, Muskellunge, Green Wood, Lake View Drive, Koth 1 and Koth Intersection Roads; in the amount of \$220,077.90. Musson Brothers, Inc. was approved to blacktop the Town Hall, Waste/Recycling Area in the amount of \$20,121.85. Motion passed 3-0 (Supervisor Joan Hilgendorf abstained from voting on the blacktopping proposals).

Hilgendorf/Koth motion to approve American Asphalt to pulverize Acorn, Wurl, Bohnert, Crystal Lake, Crystal Lake (stub), Wurl Road (stub), Deer Point, Short, Muskellunge, Green Wood, Lakeview, Koth 1 and Koth Intersection Roads; in the amount of \$12,615.15. Motion passed 4-0

Hilgendorf/Jelinek motion to approve Lakes Asphalt to do routing/crack filling on various town roads per contract in the amount of \$32,712.00. Motion passed 4-0

Hilgendorf/Eisenman motion to approve Bethel Excavating in the amount of \$8,880.00 for the grubbing to be completed on Kings Road, Koth Road, Mohawksin Road, Bayview Road and Eagle Road. Motion passed 4-0

The new plow truck was put on hold until the proposals can be narrowed down to exactly what the Town needs. Nick Weisenfeld and Gary Hilgendorf will meet with the sales reps. on Thursday, May 16th at 1:00pm to go over truck specs.

The metallic mining license ordinance (2019-1) will be acted on at a later date to give the plan commission time to read over it. The passing of this ordinance will allow the Town of Bradley to voice concerns at the county level should the need arise.

Waste/Recycling Site: Jim from Eagle Waste was not present to give an update on the site.

Cemetery Report: Supervisor Jelinek presented the board with updated cemetery fees. Jelinek/Hilgendorf motion to approve the new cemetery rates that will take effect on July 1, 2019. Motion passed 4-0

Parks & Beach Report: The Board met with Tom Emmer prior to tonight's meeting and he will be providing the town with a weekly update as to what work has been completed at the parks and beach.

Plan Commission: Hilgendorf/Eisenman motion to approve the request by Tim & Sandi Schmeltzer to allow a camper permanently on a vacant parcel with season usage. It will have electric and a holding tank, located at W6897 Mallard Lane, Tomahawk, WI. Motion passed 4-0. The next plan commission meeting will be held on Tuesday, May 28th at 6:00pm.

Road Report: At this time the blacktopping of Kahle Road will be put on hold until we see where the budget is at. The plan for summer road work will be pulverizing around the middle of June and blacktopping taking place after July 4th. These dates are weather permitting.

Other business not requiring board action: None
