Chairman Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf, John Crass and Jennifer Bishop were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$150,718.75 Equipment Fund - \$469,565.47; General Savings Account - \$343,006.95; Checking Account - \$187,001.61; Capital Outlay - \$35,000.00; Cemetery Fund - \$70,586.58; Re-Evaluation - \$90,000.00; and Greenwood Cemetery CD - \$12,561.94.
