

Town Board Meeting
December 11, 2017 5:30 P.M.
Bradley Town Hall

- 1) Call to Order: Chairman Kevin Koth called the meeting to order at 5:30pm. Present were Supervisors Bill Jelinek, Robert Eisenman and Joan Hilgendorf.
- 2) Pledge of Allegiance
- 3) Public Comment: None
- 4) Treasurers Report: Building & Office Equipment Fund-\$107,848.05; Equipment Fund - \$159,504.60; General Savings Account - \$9,725.14; Checking Account - \$172,901.65; Cemetery Fund - \$117,887.32; Re-Evaluation \$30,000.00; and Greenwood Cemetery Beautification Fund - \$12,393.49.
- 5) Minutes of Previous Meetings: November 13, 2017, November 27, 2017 and December 4, 2017 Hilgendorf/Eisenman motion to approve. Motion passed 4-0
- 6) Clerk's Business
 - A. Payment of vouchers #4765 through #4781: Hilgendorf/Eisenman motion to approve. Motion passed 4-0.
- 7) Correspondence - None
- 8) Dog Licenses: It was decided to turn all dog licenses over to the Lincoln County Humane Society effective for the 2019 licenses with Resolution 2017-3 Hilgendorf/Jelinek motion to approve. Motion passed 4-0
- 9) Poll workers: Attached list was approved for poll workers effective from 1/1/2018-1/1/2020 Hilgendorf/Eisenman motion to approve. Motion passed 4-0
- 10) Employee wage compensation-Moved to January 2018 agenda
- 11) Road abandonment on former Crass Road right-of-way: Koth/Jelinek motion to approve abandonment as there was no concerns brought to the Board during the open hearing. Motion passed 4-0.
- 12) Plan Commission made the recommendation for a conditional use request by Paul Rovang to use a camper longer than 60 days on property located at N11771 Ella Road, Tomahawk. Next Plan Commission meeting is scheduled for December 18th at 6:30pm.
- 13) Jelinek/Koth motion to approve Conditional Use request by Paul Rovang for camper use with conditions set by the county. Motion passed 4-0
- 14) Waste/Recycling Update: Slabs have been poured and compactors will be going in on Friday, December 15th. The open date is still planned for January 2, 2018. Supervisor Jelinek is working on getting signs made up to post at the new site as well as closed signs for the two old sites.
- 15) Road Report: Byron Lange stated he and Kevin will be working on the T.R.I.P. application. The Board has hired two new road employees, Kurt Bernarde and Nicholas Weisenfeld, both will be starting on December 18th. Dale Wanta will fill in part-time when needed. Discussion was had on eliminating the fuel tanks here at the Town hall. It was decided to set-up charge accounts at both the BP and the Shell for all fuel purchases and discontinuing the fuel delivery.
- 16) Any other business not requiring board action: The contract for digging at the cemetery has expired with Arnott, Supervisor Jelinek will contact them about doing a contract extension. Will look into purchasing a new pressure washer for the roads.
