Koth/Crass motion to approve the request from Dan Brandt to purchase .055ft on Bay Road. There were no concerns brought up at the public hearing. Agreement was signed between the Town of Bradley and Dan Brandt to allow the town to still turn around at the end of the road. Motion passed 4-0

Parks/Beach Report: The outhouses at Theisen Park have been cleaned. For this year they will remain as is and the town will look at purchasing a port-a-potty for next year and closing those down. The repairs needed on the fence at Theisen Park will be discussed at the July meeting.

Other business not requiring board action: Request from Deer Lake District to share our towns website was denied. If the lake districts want to provide information, they will need to have their own site.
