Chairperson Kevin Koth called the meeting to order. Supervisors Robert Eisenman, Bill Jelinek and Joan Hilgendorf were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund - \$82,324.42  
Equipment Fund - \$221,863.95; General Savings Account - \$162,844.79; Checking Account -  
\$211,270.78; Cemetery Fund - \$17,686.06; Playground Fund - \$15,691.59; Greenwood Cemetery -  
\$100,000.00 CD.

M/M Hilgendorf/Eisenman to approve the minutes from the April 15, 2014 board meeting. Motion passed 4-0.

M/M Hilgendorf/Koth to approve payment of vouchers #2147 through #2179. Motion passed 4-0.

There weren't any license applications or correspondence.

Following a long discussion the request to open Clear Lake, Essex and Half Moon Lake Roads to ATV travel; it will be placed on the June agenda.

There were no recommendations from the Plan Commission. Harry Gladwin reported that there will be a meeting on May 27th.

Byron Lange reported that the weight limits will be lifted on Wednesday May 14<sup>th</sup> except for Alery, Blum and Wadell Roads. The road crew will be hauling gravel to Nibler Road.

M/M Koth/Jelinek to accept the low pulverizing proposal from American Asphalt for Piehl and Rapel Roads. Motion passed 4-0.

M/M Koth/Jelinek to accept the low blacktop proposal from American Asphalt for Rapel Road. Motion passed 4-0.

Harry Gladwin will talk to Lincoln County Zoning concerning junk complaints at Fulsher School, A&J Sports and the horses at N9018 Hwy S. There is a trailer located on A&J Sports Bar property which was zoned for storage, and now it is being used as a residence. The septic has been hooked up to A&J Sports Bar septic system. Also, a camper has been moved onto the property.

Supervisor Jelinek is drawing up plans for the scattering garden at Greenwood Cemetery. A new computer will not be needed as a used one has now been set up for the cemetery records.

Supervisor Hilgendorf said she is looking for someone to clean Kahle Park. There are cracks to be fixed in the basketball court. The storage building at Theisen is starting to rot and needs to be fixed.

A board meeting will be held on May 27th at 5:00 P.M. to discuss the new hall addition and the equipment garage.

Changing the monthly board meeting date and/or time will be placed on the June agenda.
