- 1) **Call to Order:** Chairperson Kevin Koth called the meeting to order. Present were Supervisors Joan Hilgendorf, Bill Jelinek and Robert Eisenman.
- 2) **Pledge of Allegiance**
- 3) **Public Comment: None**
- 4) **Treasurers Report:** Building & Office Equipment Fund-\$94,163.18; Equipment Fund - \$125,785.87; General Savings Account - \$118,877.75; Checking Account - \$180,145.21; Cemetery Fund - \$117,887.32; Playground Fund - \$14,747.59; and Greenwood Cemetery Beautification Fund - \$12,331.53.
- 5) **Minutes of Previous Meeting(s):** M/M Hilgendorf/Eisenman to approve. Motion passed 4-0
- 6) **Clerk's Business**
 - A. **Payment of vouchers #3087 through #3152:** M/M Hilgendorf/Koth to approve. Motion passed 4-0.
 - B. **Liquor Licenses:** M/M Hilgendorf/Jelinek to approve the Class B beer license for Checker Flag Events, LLC, N11046 County Road A. Motion passed 4-0.

- 7) **Correspondence:** A letter was received from David Weizenicker concerning property that he had formerly owned with wetlands that have now been filled in. He had received an assessment adjustment and now feels that the adjustment should no longer apply.
- 8) **Town Website Hosting and Website Update:** Chairperson Koth explained that when **the website** ownership changed the program we were using no longer worked with By Request's program. M/M Hilgendorf/Koth to have everything updated at a cost of approximately \$400.00. Motion passed 4-0.
- 9) **Buoy ordinance for Kings Dam:** Koth will contact the applicant to let him know there is further information that the DNR needs.
- 10) **Plan Commission report and recommendations:** Wagner Oil will appear at the August 24, 2015 Plan Commission meeting.
- 11) **Board action on Plan Commission recommendations:** None
- 12) **Easement permit between the town and Robert Stebbins:** The easement for the Clear Lake turn-around was signed by the town chair and Robert Stebbins with a onetime payment of \$300.00 to Mr. Stebbins.
- 13) **Road Report:** Byron Lange reported that the blacktopping was done on all roads and shouldering will be done when weather permits.
- 14) **Grave opening prices:** Grave opening will be put out for proposals. An ad will be placed in the Tomahawk Leader.
- 15) **Cemetery Report:** Supervisor Jelinek said that the cemetery is being kept up well. Also the DNR did not fill out their report correctly in 1994. It should have stated that the well water at Greenwood Cemetery was not for human consumption.
- 16) **Park Reports:** The road crew will finish putting up the last of the playground equipment at Kahle Park.
