- 1) **Call to Order**
- 2) **Pledge of Allegiance:** Was recited at the Public Budget Hearing.
- 3) **Public Comment** - None
- 4) **Treasurer's Report:** Building & Office Equipment Fund-\$107,839.87; Equipment Fund - \$132,388.04; General Savings Account - \$9,924.34; Checking Account - \$206,342.69; Re-Evaluation - \$15,000.00; Cemetery Fund - \$117,887.32; and Greenwood Cemetery Beautification Fund - \$12,393.49
- 5) **Minutes of Previous Meeting(s):** Motion/Second Hilgendorf/Eisenman to approve the minutes of October 9, 2017, October 18, 2017 and October 30, 2017. Motion passed 4-0
- 6) **Clerk's Business**
  - A. **Payment of vouchers #4714 through #4742:** Motion/Second Hilgendorf/Jelinek to approve payment. Motion passed 4-0
- 7) **Correspondence:** None
- 8) **Road Abandonment** on former Crass Road Right-of-Way off of Hoovie and Kyes Road will be added to the December agenda so a public hearing can be held.
- 9) **Insurance Proposal from Cordova Insurance Agency-**There was not a new insurance quote presented.
- 10) **Quick Claim Deed** for William & Kerrie Butenschoen for property located at N11350 Dereg Road E, Tomahawk Motion/Second Hilgendorf/Eisenman to sign off on this quick claim deed. Motion passed 4-0
- 11) **Ordinance for Bonding of the Treasurer:** Motion/Second Hilgendorf/Koth to pass the ordinance waiving the insurance bond. Motion passed 4-0
- 12) **Plan Commission Report:** There was nothing to report the next plan Commission meeting is November 27th at 6:30pm
- 13) **Waste/Recycling:** Both sites will be relocated to the Bradley Town Hall effective January 2, 2018. We are waiting for a conditional use permit from the City of Tomahawk to install compactors. The meeting at City Hall will be held on November 29th. Hours will be the same as Tannery Dump being Tuesday, Thursday and Saturday from 9:00am-4:00pm. A new information sheet will go out to residents once all the details are finalized.
- 14) **Rapel Road:** David Bethel Sr. inquired about turning over the portion of Rapel Road from Hwy 8 to the railroad tracks over to the Town. Motion/Second Koth/Hilgendorf to go ahead with the Town taking over this portion of road with the understanding that the property owner will pay for all costs incurred.
- 15) **Road Report** - Byron Lange will try and get an address for someone at the Department of Transportation that the town can submit a letter to regarding the speed limit on Kings Road. Motion/Second Hilgendorf/Eisenman to accept the winter maintenance policy, motion passed 4-0. Will be in contact with the County regarding the winter maintenance of Tamarack Lane and what trees are really causing the problems. Shoulder clean-up has been completed on Wolf, Terrace, Klade, Acorn and part of Wurl roads. Any remaining clean-up will be completed in the spring. Adam Scherer has accepted another position and is no longer working for the Town, Mike Thayer has retired leaving the Town with one road employee. Currently accepting applications until November 16th at 10:00am. The position of Road Supervisor has been eliminated and they will all be considered Road Employees. For the winter months the road crew will be working 8 hour shifts/5 days a week. Will look at going back to 10 hours shifts/4 days a week in the spring.
