Byron Lange reported that Wadell Road has been blacktopped. Tannery Road and Crass Road are ready to be blacktopped. Wisconsin Valley Improvement has given the ok to continue work on Cottage Road, but with all the rain we have received in the last two days has now put the road under water. More work will need to be done on it before work can continue, it probably will not be blacktopped until July. Front tires on Adam's truck will need to be replaced and then aligned.

Tree on Tomahawk Trail adjacent property to Marvin Krueger will need to come down Kevin and Byron will ride out and look at it.
