

Town Board Meeting
April 17, 2018
Following the Annual Meeting
Bradley Town Hall

Chairperson Kevin Koth called the meeting to order immediately following the annual meeting. Supervisors Joan Hilgendorf, Robert Eisenman and Bill Jelinek were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$107,882.16 Equipment Fund - \$159,607.03; General Savings Account - \$275,475.16; Checking Account - \$145,384.52; Cemetery Fund - \$117,887.32; Re-Evaluation - \$30,000.00 and Greenwood Cemetery CD - \$12,393.49.

Cemetery Report: Supervisor Jelinek reported that clean-up at Greenwood Cemetery is on hold due to the weather.

Property Connections is still delinquent on their payments. A letter will be mailed tomorrow certified to them requesting payment before we get an attorney involved again.

Plan Commission: There will be a public hearing on Monday, May 14th at 5:15pm to hear the request of Joe Henrichs to rezone parcel #04.03506.001.003.01.01 on County Hwy L from Rural Residential 1 to Crossroads Mixed Use. The next plan commission meeting is scheduled for April 23, 2018 at 6:30pm.

Road Report: Any work that would need to be done on Belliveau Road is on hold at this time due to the bridge being posted on Hwy E.
