

**---NEW COLLECTION PROCEDURE FOR 2017 TAX BILLS payable in 2018---  
--Treasurer's Information and Hours --**

Please follow these instructions:

- 1) **Tear off the appropriate stub on the bottom of your tax bill,** indicate payment and mail it to the Bradley Town Hall, P.O. Box 325, with a stamped, self-addressed envelope if a receipt is requested.
- 2) You can, during the clerk's regular working hours, bring your **tax stub** along with a check **ONLY**, (**no debit or credit cards**) into the Town Hall and deposit them in the metal box placed by the treasurer's door. **If a receipt is requested, please enclose a stamped, self-addressed envelope.**
- 3) The **Treasurer** will be available at the town hall if you prefer to pay in person on Monday, Wednesday and Friday from 9:00-11:00am starting immediately when you receive your bill. December 29th **ONLY**, I will be in until 1:00. **NO holidays.** In January start up hours will again begin the week of Jan. 8th from 9:00-11:00am. January 31st **ONLY** hours will be from 12:00 – 2:00pm. If you need to mail on the last day, please make sure it is postmarked by January 31st.

**Effective at the end of 2018 all dog licenses for 2019 will have to be purchased from the Lincoln County Humane Society.**

**NOTE: HALF OR FULL PAYMENT DUE JANUARY 31, 2018.** First half is payable to the **Treasurer – Town of Bradley**. Second half of real estate taxes due July 31, 2018 payable to the **LINCOLN COUNTY TREASURER**, Lincoln County Service Center, 801 North Sales St. Suite 204, Merrill, WI 54452. All personal property taxes, special assessments, special charges, and special taxes are due by January 31, 2018. All general real property taxes of \$99.99 or less **PER PARCEL** must be paid in full by January 31, 2018.

**DRIVEWAYS:** A driveway permit must be obtained from the Town Clerk when constructing a new driveway or improving an existing driveway.

**CHECK ROAD RIGHT-OF-WAY BEFORE PLANTING, ERECTING FENCES, ETC.** The Town will not be responsible for damage to anything that is placed on the road right-of-way.

**GRASS FIRES:** Call DNR Fire Control Headquarters 715-453-2188. **DO NOT call the Tomahawk Fire Department** as you will be billed for the call.

**NOTE:** A building permit for all one and two family dwellings homes, modular homes, additions, and mobile homes, must be obtained from Town of Bradley Building Inspector David Hilgendorf 715-453-3211 prior to construction, in addition to all permits required by Lincoln County. Permits are required for all mobile homes in Lincoln County.

**MOBILE HOME OWNERS** must notify the Clerk, Treasurer or Assessor when you buy, sell or exchange a mobile home to ensure the proper real estate tax or parking fee is charged.
