

Bradley Town Board Meeting
February 13, 2023 5:30pm

Supervisor Joan Hilgendorf called the meeting to order. Supervisors John Crass and Jennifer Bishop were present. Chairman Kevin Koth was absent.

Public Comment: None

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$54,027.09 Equipment Fund - \$164,193.83; General Savings Account - \$2,567,577.97; Checking Account - \$413,730.31; Cemetery Fund - \$70,586.58; Re-Evaluation - \$90,000.00; ARPA Fund - \$123,099.40; Capital Outlay - \$20,000.00; Tax Money Collected - \$2,304,363.58; and Greenwood Cemetery CD - \$12,538.48.

Minutes of previous meeting: Monthly meeting held on January 9, 2023-Bishop/Crass motion to approve. Motion passed 3-0

Clerk's Business:

A. Payment of vouchers #8170 through #8230- Bishop/Crass motion to approve. Motion passed 3-0

Crass/Bishop motion to hold off on approving or disapproving resolution 2023-1 addressing ordinance amendments for revisions to the Lincoln County Zoning Ordinance related to permitted and conditional land uses by zoning districts. The Town of Bradley board will look at this resolution again at their March meeting once they can get clarification from the Town of Bradley Plan Commission. Motion passed 3-0

The board has set May 8, 2023, at 5:00pm to hold the special meeting for Half Moon Lake Road. Notices of this meeting will be mailed out certified to all Town of Bradley residents living on Half Moon Lake Road that will be affected by this proposed road work.

Road Report:

- The road crew worked on the 2–5-year road plan
- The 2012 freightliner was down in January and needed the rear differential replaced. While it was being worked on at Truck Country Macey used Foley's plow/dump truck. The clerk will reach out to Foley's regarding how the town will be invoiced for the use of the truck.
- Proposed road work for 2023 includes the following: Blacktopping Frontage, Kaufman and Willow Road. Nokomis Drive and Half Moon Lake Road up to the corner and the turnaround where trees were cut in the winter of 2022 will be grubbed. Oak Lane will have tree cutting and shoulder clean-up completed. Proposals for all work will go out in March of 2023 for board action at the April meeting.

Other business not requiring board action: The board agreed that the Deer Lake District could use the town's Wi-Fi for their meeting to be held on Wednesday, February 15, 2023, at the Bradley town hall.

At the March meeting the board will decide how to handle fire call billings.

As there was no other business the meeting was adjourned at 6:12PM.
