Chairman Kevin Koth called the meeting to order at 5:30pm. Supervisors Joan Hilgendorf and Jennifer Bishop were present. Supervisor John Crass was absent.

No action was taken regarding the ATV/UTV trail along Hwy 8 until the county gets clarification on how they can proceed.

Chairman Koth was updated from the Lincoln County Sheriff's office that four individuals were stopped on Tannery Road for speeding during the month of August. Two warnings were issued, and two citations were issued. The town will now investigate extending the no passing line in conjunction with decreasing the speed by 10mph.

Bishop/Hilgendorf motion to approve the request for variance by Michael and Barbara Kleen to allow for the building of a structure which is less than the minimum required street setback from town right-of-way.
