Chairman Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf, John Crass and Jennifer Bishop were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$165,913.10 Equipment Fund - \$212,424.88; General Savings Account - \$15,421.34; Checking Account - \$256,493.64; Cemetery Fund - \$70,586.58; Re-Evaluation - \$40,000.00; Capital Outlay - \$17,475.00; and Greenwood Cemetery CD - \$12,688.28.

Minutes of previous meeting: Public Hearing, Public Budget Hearing, Special Town Board and Monthly meeting all held on November 10, 2025-Hilgendorf/Crass motion to approve. Motion passed 4-0

Clerk's Business:

A. Payment of vouchers #9908 through #9954- Hilgendorf/Bishop motion to approve. Motion passed 4-0

Correspondence: The chamber presented information on implementing a room tax within the Town of Bradley. This item will be added to the January agenda.

The draft ordinance to the DNR for advisory review covering Lake Nokomis, Rice River Flowage and Bridge Lake was tabled until the January meeting.

Koth/Crass motion to approve the list to appoint poll workers for the 2026 and 2027 election cycle. Motion passed 4-0

Koth/Cras motion to approve the new contract and fees with David Hilgendorf, the building inspector for the Town of Bradley. Motion passed 4-0

The proposal from Sprinter Business to implement .gov emails will be moved to the January meeting so more information may be acquired regarding the costs and fees.

Bishop/Koth motion to approve making all Town of Bradley property closed to ATV and snowmobile use. This does not include town roads, just parks, beach and town hall. Motion passed 4-0

Waste/Recycling: Supervisor Cras will be meeting with the waste/recycling workers to discuss the changes that will be implemented starting January 1, 2026. This meeting will be held on Saturday, December 13th at 9:00am. It was determined that one 55-gallon bag or three 15-gallon size garbage bags will be allowed per trip/day.

Road Report:

- The fees for driveway permits will be increased starting January 1, 2026, to \$150.00 per permit and \$300.00 per permit if the driveway is installed prior to receiving town approval.
- Koth/Crass motion to approve the request by Bushor to install a second driveway on her property off Vacation Lane. Motion passed 4-0
- The Town of Bradley is applying for the 70/30 grant in conjunction with the Town of Tomahawk and Town of Wilson to do a stretch of Loop Road.
- Foley's is out limbing/cutting trees on various town roads that were hitting equipment or posing a safety threat. It was determined that Foley's could cut through December 9th but then the town should get an invoice, so we know where we are at cost wise before proceeding.

Other business not requiring board action: None
