

Town Board Meeting
June 9, 2025 5:30pm
Bradley Town Hall

Chairman Kevin Koth called the meeting to order at 5:17pm. Supervisors Joan Hilgendorf, Jennifer Bishop and John Crass were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$155,811.87 Equipment & Construction Fund - \$113,703.62; General Savings Account - \$415,369.55; Checking Account - \$230,869.56; Capital Outlay - \$8,875.00; Cemetery Fund - \$70,586.58; Re-Evaluation - \$40,000.00; and Greenwood Cemetery CD - \$12,640.95.

Minutes of previous meetings: Monthly Meeting held on May 12, 2025, Hilgendorf/Bishop motion to approve. Motion passed 4-0

If picnic tables get placed at the landing it will be the Friends of the Jersey Flowage responsibility to maintain them.

Plan Commission: Koth/Bishop motion to approve the request by Bradley and Mary Bucks to rezone a portion of tax parcel #004-3506-251-9988 and all of parcel #004-3506-251-9998 from Recreation to Rural Residential-3. The property is in Section 25, T35N-R6E in the Town of Bradley. Motion passed 4-0. Koth/Bishop motion to approve the request by Bradley and Mary Bucks to amend the Lincoln County Comprehensive Plan Map from Rural/Environment (Public Recreation) to Residential (Rural Single Residential) for a portion of tax parcel #004-3506-251-9988 and all of parcel #004-3506-251-9998. The property is in Section 25, T35N-R6E, in the Town of Bradley. Motion passed 4-0

Parks: The first gazebo at the beach will be put up on Wednesday, June 11th, weather permitting. Will try hydro seeding at the beach. Painting will be taking place at Kahle Park in the shelter.

Waste/Recycling: No applications were received for the waste/recycling site

Cemetery: None
