

Town Board Meeting
December 10, 2018
Bradley Town Hall

Chairperson Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf and Bob Eisenman were present. Supervisor Bill Jelinek was absent.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$107,954.19 Equipment Fund - \$187,507.22; General Savings Account - \$5,545.37; Checking Account - \$180,066.48; Cemetery Fund - \$100,813.58; Re-Evaluation - \$45,000.00 and Greenwood Cemetery CD - \$12,405.79.

Parks Report:

- A. M-J Roofing has started putting the new roof on the school at Kahle Park.
- B. Supervisor Eisenman will be purchasing wood to replace the benches at both Theisen Park and the Beach

Waste/Recycling: It was decided the animal carcass policy will remain worded as is.

Road Report: Cutting on Kings Road was started on December 6, 2018 and seems to be moving along. American Asphalt was up measuring roads for blacktopping as proposals will be going out in March. Byron and Nick met with WPS and they now have a contact person they will be able to work with. Four new back tires have been put on the tandem truck. The loader was taken in and gone through for some much needed repairs/maintenance coming in at a cost of \$6,690.82. Discussion was had on the need to look into replacing the five yard truck. Nibler Road will be sanded to protect that intersection as you come out onto Muskellunge Lake Road.
