

Town Board Meeting
June 10, 2019 5:30pm
Bradley Town Hall

Chairperson Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf and Robert Eisenman were present. Supervisor Bill Jelinek was absent.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$98,522.35 Equipment Fund - \$187,751.12; General Savings Account - \$394,833.37; Checking Account - \$71,565.26; Cemetery Fund - \$100,813.58; Re-Evaluation - \$45,000.00 and Greenwood Cemetery CD - \$12,424.56.

Plan Commission: Koth/Eisenman motion to approve the request by Charles Burton and Co-applicant Eagle Summit Healing Center to allow a minor institutional use (healing center/retreat) located in RR-1 at W5676 Water View Lane, Tomahawk. Motion passed 3-0. Hilgendorf/Koth motion to approve the request by Russell and Sara Lane for an accessory storage building larger than 2,000 square feet in RR-3 located at N8916 Stegman Road, Tomahawk. Motion passed 3-0.

Dale Weickardt was in to discuss his request to purchase a strip of land from the Town of Bradley for property located on Deer Lake Road. This request will be moved to the July agenda so the Board has time to look over the request and Chairman Kevin Koth can discuss with surveyor Festus Schmit on parcel ownership and if a public hearing is necessary.

The Lincoln County zoning ordinance related to short term rental was put on hold until after the July 11th public hearing at Lincoln County.

Koth/Hilgendorf motion to approve the proposal from Wisconsin Kenworth for a new plow truck in the amount of \$109,875.00 and the truck equipment attachments from Monroe Truck Equipment in the amount of \$74,269.00. Motion passed 3-0.

Road Report: Pulverizing started today (June 10th), the road crew along with the county will put down gravel on the roads starting next week and then blacktopping will take place after the 4th of July weather permitting. Road employee Nick will contact McCoy to get a price on installing air conditioning in the front end loader.

Mowing Proposal: Hilgendorf/Eisenman motion to approve the mowing proposal from Chuck Theiler to do the mowing along all town roads in the amount of \$55.00/hour same as last year. Motion passed 3-0.

Parks & Beach Report: Supervisor Hilgendorf had contacted Jerry and Lenny Bartz about doing work at the parks and beach as needed but has not heard back from them. We will also be putting a call into Justin Lemke to see if that is something he is interested in doing. Supervisor Hilgendorf is still putting together specs. for installing dug outs at Kahle park. After the last wind storm that went through there are a number of trees down at the beach that will need to be cleaned up.
