

Town Board Meeting

June 8, 2020 5:30pm
Bradley Town Hall

Chairman Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf, Bob Eisenman and John Crass were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$36,295.37 Equipment Fund - \$27,616.99; General Savings Account - \$213,155.49; Checking Account - \$202,273.30; Cemetery Fund - \$100,813.58; Re-Evaluation - \$60,000.00; and Greenwood Cemetery CD - \$12,460.25.

Tannery Road Multimodal Project proposals were discussed. Koth/Eisenman motion to approve the proposal from Pitlick & Wick in the amount of \$544,160.85 to complete the work. Motion passed 4-0

Road Report:

- Koth/Crass motion to approve Pitlick & Wick to blacktop Red Pine Road from Tannery Road to the curve in the amount of \$36,139.50. Motion passed 4-0
- The road crew finished working on the shoulders and seeded Kings Road
- Short Road had wash-out issues that has been fixed
- Crack sealing is finished
- Truck #5 received two new tires
- The road crew will look at getting socket organizers for the new tool box in the shop

Eisenman/Crass motion to approve Chuck Theiler to the road mowing this year in the amount of \$55.00/hour. Motion passed 4-0

Cemetery Report: Hilgendorf/Koth motion to approve the installation of a bench near the scattering garden in honor of Supervisor Jelinek and his years of service. Motion passed 4-0 The concrete pad has been poured at the cemetery and now the columbarium will be set. It was noted that the new columbarium will only hold one cremation per niche.

Parks/Beach Report:

Signs have been posted at Kahle Park reminding users of the park that dogs are not allowed at the park. The port-a-potties have been removed from Kahle Park and the beach. Will talk with Bob Dotter about fixing the basement door at Kahle park and replacing the cover on the well that is down there.

Building & Grounds Report:

Eisenman/Hilgendorf motion to approve Time-Lapse Cleaning to do a deep clean of the town hall in the amount of \$900.00. Motion passed 4-0 A mail slot will be installed at the town hall to provide a spot for people to drop off absentee ballots, tax payments or other misc. information.
