

Town Board Meeting
July 11, 2022, at 5:30pm
Bradley Town Hall

Chairman Kevin Koth called the meeting to order. Supervisors Joan Hilgendorf, Jennifer Bishop and John Crass were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$43,886.67 Equipment Fund - \$114,053.38; General Savings Account - \$528,138.82; Checking Account - \$220,722.82; Cemetery Fund - \$70,586.58; Re-Evaluation - \$90,000.00; Capital Outlay \$10,000.00; ARPA \$246,922.30; and Greenwood Cemetery CD - \$12,515.06.

Minutes of previous meetings: Monthly Meeting on June 13, 2022 & Special Meeting on June 30, 2022 Hilgendorf/Bishop motion to approve. Motion passed 4-0

Clerk's Business:

Hilgendorf/Crass motion to approve Resolution 2022-2 Lincoln County ordinance amendment related to shoreland zoning. Motion passed 4-0

Lincoln County Clerk Chris Marlow discussed the need to replace the 2006 handicapped accessible voting machine. It has reached its shelf life and will need to be replaced. The cost of a new machine is roughly \$4,000.00. The county will be putting together a team to look at options for new election equipment since the voting machine that reads ballots is also reaching its shelf life.

Bishop/Koth motion to approve the Deer Lake no wake buoy request that they will be submitting to the DNR. Motion passed 4-0

Hilgendorf/Bishop motion to approve the 2022 budget amendments for lost revenue with ARPA funds. Motion passed 4-0

Plan Commission: No applications

Cemetery Report: The cemetery now has its own tab on the town's website.

Parks/Beach Report: Bishop/Hilgendorf motion to approve the proposal from Countryside Fence to make repairs on the upper fence at Theisen Park in the amount of \$10,778.00. The new fence will be going in at Kahle Park the end of August or first part of September. They will be moving the fence in to make the outfield little league length.

Road Report:

- Crass/Koth motion to approve the extended warranty on the grader. This will cover the grader on an as needed basis.
- The town will be meeting with residents on Halfmoon Lake Road on Wednesday, July 20th at 3:00pm to go over future road work plans. The town received deeds for all property owners on that road and nothing stated what road right-of-way is.
 - Road work is now completed on Frontage and Kaufman Road
 - The boat landing on Oak Lane is now fixed
 - Tree cutting will take place on Nokomis Drive to help with the turn around at the end of that road.
